- A. Aquatic Center Issues
 - a. Last contract negotiated 2018. We owe 15 K in usage fees per year since then (75K) that have not been billed to us. This was an oversight on the team and FCCA for not monitoring the contract closely.
 - FCCA agreed to accept a negotiation of having 2 heaters replaced at A/C and a heater installed at crescent lakes to initiate lessons. - crescent lakes is part of expansion project, not part of the 75K
 - c. Fees have not been raised since 2011. A new rate will be created by FCCA
 - d. A new contract will be negotiated with FCCA
- B. New pump rooms
 - a. New pump rooms need to be considered for settlers park and colony grant 6.
 - i. We will attempt to discuss with HOA's to split cost
- C. New Senior Group for first colony
 - a. Senior Elite, Senior 3, Senior 2, Senior 1.
 - i. We will hire in house
 - ii. Program will begin in short course
